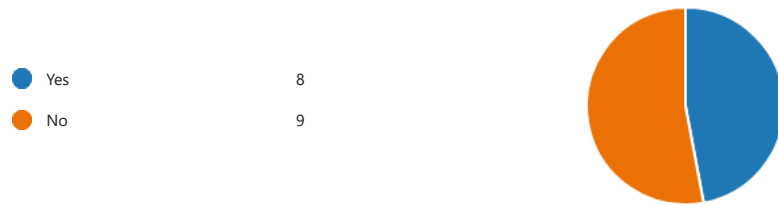

1. Is this your first time attending a Pre-Conference Institute for PAIMI Council Members

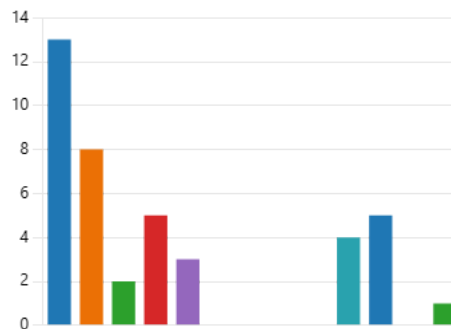


2. From most important (top position) to least important (bottom position) rank your reasons for attending this year's Pre-Conference Institute for PAIMI Council Members.



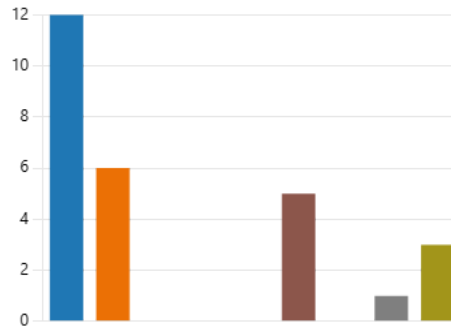

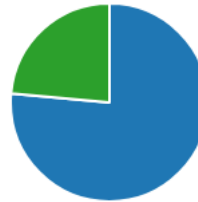
